Brent, Marion and Randy Lints were before Council to discuss drainage concerns on NE 20-15-24 WPM. There is a ditch on the property that was constructed by the municipality in the 60's. Maintenance of the ditch has been a problem over the years with beaver, snow and blocked culverts causing water to back up and flood his land. The municipality has cleared the snow for 30 years and this year he had to do it himself or he would have flooded badly. Like everyone Brent makes his living off the land and costs like this hurt the viability of farming. He was looking for a solution to the problem and compensation for the costs he had incurred.

Council asked questions of clarification and felt it was important to include all of the affected neighbors to come up with a long term solution. Brent was agreeable to such a meeting.

Council thanked the delegation for taking the time to come out and discuss the issue.

• 7:30 pm Peter Hamilton – Drainage - Oakner

Peter Hamilton and Jim Bomford appeared before Council to discuss drainage concerns with drainage in the Oakner area. There are problems with water backing up at the railway tracks and there is poor flow to the south. Council has been dealing with this issue and municipalities to the south have suggested that a meeting be held to identify concerns and rectify them. Manitoba Water Stewardship indicated on the last application for drainage improvements in the area they would require consent from downstream Municipalities or the application could not precede.

Mr. Bomford felt an overall drainage plan would help with dealing with this issue.

Council agreed that they would meet with neighboring jurisdictions as time permitted and let the delegation know the results.
