Louise Stitt and Neil Gamey were before Council to present on the EMS in
Hamiota. Currently there are 5 EMS staff in Shoal Lake, 3 in Birtle and 1 in
Hamiota. Coverage for the area has been difficult. There have been times
when there has been no staff available and coverage comes from outside the
area. From February 2016 to January 2017 Hamiota has been out of service
5.004 hours.

Call volume from April 1, 2016 to January was 24 9-1-1, 18 9-1-1 cancelled and 41 interfacility. Of all the 9-1-1 calls made on average 10% are emergent. It is proposed that there will be a staff person working four days on and four days off. Not full time but an improvement on the existing service. Hamiota still makes use of some very dedicated casual staff.

If there were people interested in a career in EMS PMH would be happy to discuss it with them. There may also be opportunities to be a casual stand by technician.
