HAMIOTA MUNICIPALITY

BY-LAW NO. 2019-05

Being a By-Law of Hamiota Municipality to amend its By-Law No. 9/2016 Internet distribution infrastructure

WHEREAS, Hamiota Municipality, by its By-Law No. 9/2016, which was authorized by Municipal Board Order No. E-17-018, is inter alia, authorized to issue borrowing in the amount of \$3,500,000.00;

AND WHEREAS, no borrowing as authorized by said By-Law No. 9/2016 has been issued or sold;

AND WHEREAS, Hamiota Municipality has made arrangements to borrow Series "A" from the Minister of Finance of the Province of Manitoba in the amount of \$2,500,000.00, being the partial costs of works completed under the authority of By-Law No. 9/2016, such borrowing to be dated the 30th day of November, 2019, to bear interest at the rate of 3.500% per annum, payable annually during their currency, and to mature on November 30th in each of the years 2020 to 2039;

AND WHEREAS, Hamiota Municipality has made arrangements to borrow Series "B" from Hamiota Municipality's Equipment Reserve Fund in the amount of \$225,000.00, being the final costs of works completed under the authority of By-Law No. 9/2016, such borrowing to be dated the 30th day of November, 2019, to bear interest at the rate of 3.500% per annum, payable annually during their currency, and to mature on November 30th in each of the years 2020 to 2039;

AND WHEREAS, it is deemed expedient to amend said By-Law No. 9/2016 to provide for the issuance of the aforesaid borrowing;

NOW THEREFORE, the Council of the Hamiota Municipality, in council duly assembled, hereby enacts as follows:

- 1. **THAT** By-Law No. 9/2016 of the Hamiota Municipality **BE AND THE SAME IS HEREBY AMENDED** to provide that Series "A" borrowing in the amount of \$2,500,000.00 be issued to cover the costs of works completed thereunder; such borrowing to be dated the 30th day of November, 2019, to bear interest at the rate of 3.500% per annum, payable annually during their currency; and to mature in accordance with the maturities set out in Schedule "A-1" hereto on the 30th day of November in each of the years 2020 to 2039, both inclusive.
- 2. **THAT** By-Law No. 9/2016 of the Hamiota Municipality **BE AND THE SAME IS HEREBY FURTHER AMENDED** to provide that Series "B" borrowing in the amount of \$225,000.00 be issued to cover the costs of works completed thereunder; such borrowing to be dated the 30th day of November, 2019, to bear interest at the rate of 3.500% per annum, payable annually during their currency; and to mature in accordance with the maturities set out in Schedule "A-2" hereto on the 30th day of November in each of the years 2020 to 2039, both inclusive.
- 3. THAT the issue of said borrowing provides financing for all costs of works completed under authority of By-Law No. 9/2016, and the balance of \$775,000.00 of authorized borrowing which will not be required or used is hereby cancelled.
