BY-LAW NO. 02-2015

BEING A BY-LAW OF HAMIOTA MUNICIPALITY TO ESTABLISH THE ORGANIZATIONAL STRUCTURE OF THE MUNICIPALITY

The Council of Hamiota Municipality enacts:

1. Purpose

The purpose of this by-law is to establish the organizational structure of the Municipality as directed by Section 148 of *The Municipal Act*.

- **2. Head of Council.** The Head of Council shall have the title of Reeve.
- 3. **Deputy Reeve**. The Deputy Reeve is appointed by resolution of Council at the first regular meeting of Council following either a general election or when necessary. The Deputy Reeve shall act in place of the Reeve when the Reeve is unable to carry out the functions of Head of Council.
- 4. **Board of Revision**. Boards of Revision will be comprised of all Members of Council, or some Members of Council and other Members as appointed by resolution of Council. The Secretary of the Board of Revision shall be the Chief Administrative Officer unless otherwise detailed by resolution of Council.
- **Signing Authority**. Agreements, cheques and other negotiable instruments must be signed or authorized by:
 - a. The Reeve or the Deputy Reeve or any other Member of Council so designated by resolution of Council; and
 - b. The Chief Administrative Officer, or the Assistant Chief Administrative Officer
- **6. Standing Committees of Council**. The following Committees are established, with areas of responsibility shown. Members will be recommended by the Reeve, and approved by a resolution of Council, as shown on Schedule A. Schedule A may be amended by resolution of Council as required.
 - a. Committee of the Whole Council. This Committee is composed of all Members of Council present sitting as a Committee.
 - b. Finance and Administration
 - maintenance of all records of the Municipality
 - managing of Conditions of Employment
 - human resource management
 - administrative support to all departments
 - finance and budgeting
 - by-laws and policies are current and relevant
 - research and develop policy and by-laws as directed by Council
- **c.** Works and Operations
 - fire departments
 - police services
 - animal control services
 - emergency measures
 - coordination of the efforts of all these departments
 - municipal infrastructure such as roads and drains
 - Public Works vehicles and equipment
 - solid and liquid waste management facilities



- re-cycling and other environmentally conscious programs
- cemeteries
- 7. **Duties of Council Committees.** Committees are responsible to:
 - be knowledgeable about operations and staff
 - be familiar with budgets and staff
 - study issues and recommend action
 - develop and recommend policy
 - represent Council when so directed
- 8. Intermunicipal Boards and Associations. Members of council may be appointed by resolution as representatives to various intermunicipal boards and associations. These representatives shall report to council regarding the activities of the bodies to which they have been assigned.
